VEHICLE HAS MINOR REAR END DAMAGE. DIRECT IMPACT TO CENTER AREA OF RR BUMPER COVER. THE COVER HAS MINOR DEFORMATION ON TOP SIDE, PAINT HAS MINOR CRACKS THROUGH OUT IMPACTED AREA.

THE VEHICLE HAS U.P.D. DAMAGE TO THE LEFT SIDE OF RR BUMPER COVER. U.P.D. DAMAGE REQUIRES FULL REFINISH, NO REFINISH GIVEN FOR NEW DAMAGE.

CLAIMANT INDICATED SHE HAD NEW LOSS RELATED DAMAGE TO THE FRONT END AS WELL. SHE STATED THAT THE VEHICLE IN FRONT DID NOT STAY TO EXCHANGE INFORMATION.
